PROFILE OF REGIONAL TRAINING INSTITUTE, NATIONAL ACADEMY OF CUSTOMS, EXCISE & NARCOTICS (NACEN), COCHIN

The Regional Training Institute, NACEN, Cochin was formed in October, 2014 consequent upon the cadre restructuring and re-Organisation of field formations under Central Board of Excise & Customs as communicated vide F. No. 11019/08/2013-Ad. IV dated 01.08.2014. The RTI was inaugurated on 15.12.2014 by Smt. Sheena Shukkur, Pro vice chancellor, Mahatama Gandhi University, Kottayam in the presence of Dr. G. Sreekumar Menon, former Director General, NACEN, Shri. M. Ponnuswamy, former Additional Director General, Chennai and the Commissioners of Central Excise and Customs House, Cochin Ms. Reshma Lakhani and Dr. K. N. Raghavan.

The RTI, NACEN, Cochin is presently catering to the training requirements of about 2700 officers posted in the following formations in Kerala Zone.

- (i) Chief Commissioner's office, Kerala Zone, Cochin
- (ii) Central Excise, Customs and Service Tax Commissionerate, Cochin
- (iii) Audit Commissionerate, Cochin
- (iv) Commissioner (Appeals I & II), Cochin
- (v) Custom House, Cochin
- (vi) Customs Preventive Commissionerate, Cochin
- (vii) Central Excise, Customs and Service Tax Commissionerate, Calicut
- (viii) Central Excise, Customs and Service Tax Commissionerate, Thiruvananthapuram
- (ix) Regional Unit, DGCEI, Cochin
- (x) Regional Unit, DRI, Cochin (with sub units at Calicut and Thiruvananthapuram)

Prior to the formation of NACEN, Cochin, the training requirements of the officers in Kerala Zone were taken care of by RTI, NACEN, Bengaluru. The Additional Director General, NACEN, Chennai was in-charge of NACEN, Cochin from its inception to May, 2015. Consequent upon the retirement of the ADG, Chennai, the Principal Additional Director General, NACEN, Bengaluru held additional charge of the RTI till 28.08.2015. Thereafter, the Principal Additional Director General, RTI, NACEN, Hyderabad is holding charge of the RTI, Cochin.
