National Academy of Customs, Indirect Taxes and Narcotics, Faridabad is organizing a One week training programme on "Greening of Offices" for the Group 'A' officers of CBIC from 27th to 31st August, 2018 in collaboration with International Centre for Environment Audit and Sustainable Development (iCED), Jaipur.

- 2. It is a five days fully residential course. Boarding and lodging for the participants will be provided by iCED and the training cost (except Travelling Allowance) will be reimbursed by NACIN to iCED, Jaipur directly.
- 3. Nominations in the level of AC/DC/JC/Addl. Commissioner for the said course may be forwarded to NACIN, Faridabad especially by those Zones / Commissionerates under whose jurisdiction various infrastructure proposal of the department are currently underway. Priority may be given in respect of those projects which have been sanctioned and construction has already started or are about to be started. The nominations may be sent not later than 17th August, 2018. The telephone/mobile numbers and e-mail address (in capital letters) of the nominated officers should also be indicated in the nomination letters so as to facilitate ease of contact/communication.
- 5. NACIN, Faridabad will intimate the officers as well as their controlling officers for joining the course after due selection is done by NACIN. Therefore, it is requested to ensure that officers do not report for the aforesaid course at iCED, Jaipur, unless a confirmation of selection is received from NACIN, Faridabad.

It may kindly be ensured that once nominated, the officer must report at iCED, Plot no-SP 6&7, RIICO Industrial Area, Kant-Kalwar, near Vachrol, Jaipur, Rajasthan-303002 for attending the training programme, on the 26th August, 2018, as last minute cancellation/withdrawal results in considerable administrative and financial issues.
