- 2. In this era of globalisation, officers of CBIC have a stellar role to play in the effective implementation of various International Customs Conventions and Agreements. No wonder, it is said that "Borders Divide, Customs Connects". After this two-days' training, the participants will refresh and acquaint themselves about basic principles and practical aspects of International trade and India, about WCO and WTO, functioning of WCO CLiCK Module and various Customs Conventions & Agreements like HS Convention, Revised Kyoto Convention, Basel Convention, SCOMET, CITES, Montreal Protocol, OPCW and Mutual Administrative Assistance (MAA) on Customs Matters, MAA arrangements of India etc. They will also be walked through, inter-alia, Single Window (SWIFT), Advance Passenger Information System and National Targeting System (NTS).
- 3. It is, therefore, requested that suitable Group 'A' officers, may be nominated for participating in the above course.

The telephone/mobile numbers, e-mail address (in capital letters) and Employee ID of the nominated officers may also be indicated in the nomination letter so as to facilitate ease of communication.
- 5. It is, further, requested that hard copy of nomination may not be sent separately through courier or by post so as to avoid wastage of paper.
- 6. It may kindly be ensured that the officer once nominated should attend the training course as last minute cancellation/withdrawal results in considerable administrative and financial issues.

- 7. It may be mentioned that limited hostel facilities are available for the participants, who wish to stay in campus. For the participants, the hostel and mess charges (all inclusive) shall be approximately Rs. 400/- per day. This includes Rs. 100/- room rent, Rs. 100/- Breakfast + bed tea, Rs. 200/- for dinner. Rs. 250/- for lunch and tea/snacks (twice a day) is to be paid separately at the time of registration by all the participants.
