
Please refer this office letter C.No. I/04/02/2019 dated 21.5.19 and further Corrigendum dated 28.5.19, notifying the examination dates for the promotion of Ministerial Officers to the grade of Inspectors of Central Tax / Inspectors of Customs (EO/PO) in August 2019, and letter C.No. I/04/04/2019 dated 21.6.19 notifying the examination dates in September 2019, for the promotion of Tax Assistants to Executive Assistants.

Several queries have been received by this office seeking clarification regarding the eligibility of the candidates to appear for the above two examinations. It is once again brought to the notice, that the above two examinations were held as a combined examination till last year and from this year onwards, the examinations for the promotion to the grade of Inspectors and the examination for the promotion to the grade of Executive Assistants would be conducted separately as notified by NACIN, Faridabad. In this regard, please find enclosed letter F.No. II(15)90/NACIN/Calendar/2019/2297 wherein, the ANNUAL CALENDAR FOR DEPARTMENTAL EXAMINATIONS was circulated by NACIN, Faridabad allotting the exam dates for various departmental examinations to be conducted in the year 2019-2020.

The Cadre Controlling Commissionerates may take cognizance of the Annual Calendar issued by NACIN, Faridabad (Copy enclosed) and the relevant Recruitment Rules to decide on the eligibility of the candidates.

As per DG, NACIN instructions, only queries relating to the process of conducting examination will be clarified by this Office. The determination of eligibility to appear for the above two examinations will not come under the purview of this Academy as the Cadre Controlling Authorities would have to decide on the same.

Cadre Controlling Authorities are the best judges of the promotional aspect of their staff or reservation policy, as per the Recruitment Rules or any other Rules & Regulations issued by the Ministry or the Board. They may approach NACIN, Faridabad for any fresh examination to be conducted, due to any exigency. Determination of eligibility to appear in the examination and declaration of result is also the prerogative of the respective Cadre Controlling Authority.
