4. **It is, further, requested that hard copy of nomination may not be sent separately through courier or by post so as to avoid wastage of paper.**


5. It may kindly be ensured that once nominated, the officer must report for attending to the training course as last minute cancellation/withdrawal results in considerable administrative and financial issues.

Rs. 250/- for lunch and tea/snacks (twice a day) is to be paid separately at the time of registration by all the participants. 
