OFFICE ORDER

Ministry vide Office Order No. 06/Ad.IV/2017 dated 12th June, 2017 issued from file No. A-11013/172017-Ad.IV conveyed the approval of the Competent Authority to rename the National Academy of Customs, Excise & Narcotics (NACEN) as "National Academy of Customs, Indirect Taxes & Narcotics (NACIN)". Vide the said Office Order the Charter of Function of National Academy of Customs, Indirect Taxes & Narcotics (NACIN) has been indicated as:

"Training and other Capacity Building activities in the field of Customs, Indirect Taxes and Narcotics, including –

- (i) induction training of directly recruited Gr-A officers,
- (ii) specialized and periodic training to in-service-officers,
- (iii) induction training to "Gr-B & C officers",
- (iv) training to State/UT and other stake holders in the area of indirect taxation,
- (v) management and soft skills training for overall professional and personal development of officers,
- (vi) International cooperation and training activities in Customs, Narcotics, and other allied areas.
- (vii) Any other capacity building activity as may be assigned by CBIC from time to time,
- (viii) Carry out the normal administrative & establishment functions and duties of Central Government offices, appurtenant thereto.
- 2. NACIN Academy will have its Headquarter at Faridabad (Haryana) with Zonal and Regional campuses across the country, including Centre of Excellence (CoE) for research work in the field of indirect tax and related areas. The existing Regional Training Institutes (RTIs) have been rechristened as Zonal Training Institute (ZTIs). NACIN has been strengthened by creating four new ZTIs at Chandigarh, Jaipur, Vishakhapatnam and Bhubaneshwar and two Regional Training Institutes at Raipur and Ranchi.
- 3. Each ZTI will be headed by Pr. ADG/ADG rank officer and each RTI will be headed by ADD/JD rank officer. The jurisdiction of the ZTI/RTI will be as under:
