The bids will be opened on 31.08.2018 at 3 P.M.

## ANNEXURE-I (TERMS AND CONDITIONS)

#### GENERAL TERMS AND CONDITIONS:

- 1. The bidder should be a reputed/established contractor and should have experience of minimum 5 years in the field.
- 2. The bidder should be registered with the jurisdictional GST office and any other registrations required as per the existing Laws relating to his business
- 3. Bidder should provide the copy of the Income Tax returns filed by him during the last three years along with his bid.
- 4. The bidder should have adequate experience in carrying out civil work in commercial buildings. The bidder should have undertaken civil works in Government organizations and should enclose proof for having executed such works along with the technical bid.
- 5. The bidder should provide all details along with copies of the relevant documents as listed at Annexure -II of this tender document.
- 6. The bid should be accompanied with an Earnest Money Deposit of Rs.20,000/-(Rupees Twenty Five Thousand only) in the form of D.D. addressed to the "DDO, NACIN, Faridabad. The EMD of the unsuccessful bidders will be returned within 10 days of finalization of the tender. The EMD of the successful bidder will be returned on successful completion of the project.

#### TECHNICAL REQUIREMENTS/CONDITIONS:

The interested vendors may submit their bid in two parts: 1) The Technical Bid and 2) The Financial Bid. The Technical Bid should cover all the technical specifications of the civil work they will be undertaking for Installation of outdoor ring fountain and one three step stone fountain along with the relevant drawings. All the necessary documents as required in the General Terms and Conditions should be enclosed to their Technical Bid.

The Financial Bid should cover the pricing of the project indicating the tax factor separately. The pricing should include all material and labour charges which should be shown separately in the bid. Rates will be quoted in figures and words and in the event of any difference in the two rates, the rates quoted in words will prevail.

The Technical Bid will be opened first and the Financial Bids of only those who have qualified in the Technical Bids will be opened.

The bidder should also indicate the time frame in which he would complete the project along with the Technical bid which should be accepted by NACIN, Faridabad. In the event he fails to do so in the stipulated time, NACIN reserves the right to impose a penalty of 1% of the contract amount on the bidder.

Payments will be made to the bidder in full only on successful completion of the project and on due certification of the officer In-charge at NACIN for monitoring the project. The DG, NACIN shall be at liberty to withhold any payments in full or in part for any default in supply or installation of the product.

The period of guarantee/warranty offered by the bidder for the work done should be clearly indicated in the Technical Bid and the bidder should undertake to rectify any defects noticed by NACIN during that period at no extra cost.

The DG, NACIN reserves the right to award the contract in full or in part without assigning any reasons.

The DG, NACIN, Faridabad reserves the right to reject any tender without assigning any reasons thereof.

#### ANNEXURE-III

- 1. The bidder should install two fountains of different specifications i.e. one outdoor ring water fountain adjacent to the front gate of the academy and one three step stone fountain near Hall No. 3 of the Academy.
- 2. The proposed fountain to be installed at the front gate would have 03 step outdoor ring water fountain with 1<sup>st</sup> ring dia-8ft, 2<sup>nd</sup> ring dia-4ft, 3<sup>rd</sup> ring dia-4ft, 1<sup>st</sup> ring nozzle-48, 2<sup>nd</sup> nozzle-24, 3<sup>rd</sup> ring nozzle-24, Light-18, Motor- Kirloskar/Cromton-7.5 HP-01, Motor Contrtoller-1, Light Controller-1, Concrete work with tiles, 1<sup>st</sup> round tank 10ft dia & hight 2ft, 2<sup>nd</sup> round tank 5ft ft dia & hight 2ft and 3<sup>rd</sup> round tank 5 ft dia & hight 2ft. The above work includes, all kind of material, cement, Bricks, wall valves unions other fitting etc if needed to complete the work.
- 3. The 2<sup>nd</sup> three step stone fountain to be installed near the Hall No. 3 would have <sup>3</sup>/<sub>4</sub> layer/tiered water fountain of marble stone and 8ft dia. The materials used should be of good quality and of reputed brand. The above work includes, all kind of material, cement, Bricks, wall valves unions other civil and electrical fitting etc if needed to complete the work.
- 4. All the material supplied should have of high quality fittings of reputed brands.
- 5. The bidder should complete all the electrical works required in the fountains lights. The electrical materials/items provided should be of a reputed brand.
- 6. A sample of the materials to be provided should be shown to evaluation committee of the project before the work is executed. The colour of the stone/tiles to be used will be decided in consultation with the evaluation committee.
- 7. Bidder can visit NACIN on any working day between 3pm to 5 pm to see the site where fountain is to be installed.
- 8. Any other technical requirements beyond the scope of the above referred specifications may be brought to the notice of NACIN at the time of opening of bid and NACIN reserves the right to accept or reject the same.
