ANNEXURE-I (TERMS AND CONDITIONS)

- 1) National Academy of Customs, Excise & Narcotics, RTI, Bengaluru having its office at No.40, HMT factory Main Road, Next to HMT School, Jalahalli, Bengaluru-560 013. Complex consisting of three blocks viz: Administrative &Training block, Sports & Auditorium complex and Hostel block.
- 2) NACEN complex comprises of the following three blocks spread over an area of 9321 sq.mts:
 - (i). <u>Administrative and Training Block</u>: This building of 4328.96 sq metres and consists of 5 Floors which houses 6 Lecture Halls, 4 Group Discussion Rooms, 2 Computer Training Rooms, a Library, a Conference Room, Chambers for all RTI officials.
 - (ii). <u>Hostel Block</u>: This building of 3122.99 sq metres and consists of ground floor and 4 Floors having 30 Single Rooms, 36 Double Rooms, 12 AC Rooms and 5 Suites. The Ground floor of the block houses a cafeteria with dining facilities for the trainees and visiting faculty members. This block also has 2 Staff Quarters.

The bidder should carry out the following wiring work to enable intercom connections in the premises and should provide interconnectivity between the three complexes thereon:

- a) Provide wiring between the EPABX on the 4th floor of the Administrative block and the Ground floor of the Hostel complex using a 100 pair PVC cable
- b) Further provide 85 connections in the hostel block in consultation with the designated officer of the Academy using 2 pair PVC cable.
- c) The bidder should also provide wiring in the Administrative block as per the requirement of the Academy by using 2 pair PVC cable.
- d) The bidder should provide wiring in the sports block of the academy by using 20 pair PVC cable from the EPABX to the ground floor of the sports complex and further connections within the sports complex as required by the Academy using 2 pair PVC cable.
- e) The bidder shall also provide a wiring to the security room at the gate from the sports complex using a 2 pair PVC cable.
- 4) The bidder should be a reputed/established service provider having a minimum experience of 4-5 years in the field of providing telephone cabling.
- 5) The bidder should be registered with the jurisdictional Commercial Tax Office / Service Tax and any other registrations required as per the existing laws relating to his business.
- 6) The bidder should have a minimum annual turnover of Rs. 50 lakhs atleast during two financial years in the preceding three years. In support of the same, a copy of the balance sheets for the said years should be enclosed to the bid.

- 7) The bidder may also submit the Income Tax returns filed by him during the last three years.
- 8) The bidder should have adequate experience in providing EPABX wiring/cabling as per the specifications to Government organizations/Public sectors/reputed Private Ltd. companies. Proof for having executed projects of this nature in the organizations mentioned above may be provided along with the bid.
- 9) The bidder should provide all details along with copies of the relevant documents as listed at Annexure -II of this tender document.
- 10) The bid should be accompanied with an Earnest Money Deposit of Rs. 25000 in the form of D.D. addressed to the "Pay & Accounts officer, Central Excise, Bengaluru. The EMD of the unsuccessful bidders will be returned within 10 days of finalization of the tender. The EMD of the successful bidder will be returned on successful completion of the project.
- 11) The interested vendors may submit their bid in two parts: 1) The Technical Bid and 2) The Financial Bid. The Technical bid should cover all the technical specifications of their products for wiring/cabling and all the necessary documents as required in paras (4) to (9).
- 12) The Financial Bid should cover the pricing of their products/installation and should be inclusive of all taxes. Rates will be quoted in figures and words and in the event of any difference in the two rates, the rates quoted in words will prevail.
- 13) The Technical Bid will be opened first and the Financial Bids of only those who have qualified in the Technical Bids will be opened.
- 14) The bidder should indicate the time frame in which he would complete the project along with the Technical bid which should be accepted by NACEN, Bengaluru. In the event he fails to do so in the stipulated time, NACEN reserves the right to impose a penalty of 2% of the contract amount on the bidder.

- 15) Payments will be made to the bidder in full only on successful completion of the project and on due certification of the officer Incharge at NACEN for monitoring the project. The Pr.ADG, NACEN shall be at liberty to withhold any payments in full or in part for any default in successful completion of the wiring project.
- 16) The period of guarantee/warranty offered by the bidder for the cables laid should be clearly indicated in the technical bid and the bidder should undertake to rectify any wiring defects noticed by NACEN during the period of warranty at no extra cost.
- 17) Pr.Additional Director General, NACEN reserves the right to award the contract in full or in part in respect of the tendered item without assigning any reasons.

18) Pr.Additional Director General, NACEN, Bengaluru reserves the right to reject one or all the bids received without assigning any reason whatsoever.
