- **5.** The item to be supplied should be of good quality. The items should not suffer any type of damages at the time of delivery.
- **6.** In case of any accident/ damage occurred during the course of supply of the above items, all the claims arising out of the same shall be met by the firms/dealers/agencies and NACEN, Chennai shall have no liability whatsoever in this regard.
