Our Vision



To create an institution of excellence where people can achieve full potential in their academic, creative, personal, physical, moral and ethical development.

EVOLUTION

In the year 1955, the then Central Board of Revenue decided to set up a Central Training School with a view to improve general efficiency of the Central Excise Service. The Central Training School started functioning from 01.10.1955 and over the years, it evolved into 'Directorate of Training' with the mandate to impart induction training to newly recruited IRS (C&CE) officers. In the year 1989, the name was changed to National Academy Customs. Excise and Narcotics (NACEN) and recently with the advent of Goods & Services Tax (GST), it has been renamed as National Academy Customs, Indirect Taxes and Narcotics (NACIN).

ORGANIZATION

The National Academy of Customs. Indirect Taxes and Narcotics (NACIN) is the apex institution of the Government of India for capacity building in the field of indirect taxation. Specifically, the training activities fall in the areas of Indirect Taxes(Customs, Central Excise, Goods & Services Tax) and Narcotics Control administration. The Headquarters of NACIN is located at Faridabad, Haryana in the National Capital Region. The Academy falls under the administrative control of the Central Board of Indirect Taxes and Customs Department (CBIC), Revenue, Ministry of Finance, New Delhi.

NACIN is headed by the Pr. Director General who is an officer of the Indian Revenue Service (Customs & Central Excise) at the rank of Special Secretary to the Government of India. The Pr. Director General is assisted by a team of Principal Additional Directors General, Additional/Joint Directors General, Additional Directors, Deputy Directors and Assistant Directors.

NACIN's flagship programme is training of direct recruit IRS (C&CE) officers. Over the last two decades. NACIN along with its Training Institutes has been conducting professional training programme for direct recruit IRS (C&CE) officers. The year-long programme starts in the month of December each year, after completion of three months' Foundation Course of the officer-trainees at Lal Bahadur Shastri National Academy of Administration. Officer-trainees trained in the administration of Customs, Central Excise and Goods & Services Tax (GST) through a combination of class room sessions and visits to various field formations across the length and breadth of the country. In addition, short visits are also organized to other prominent agencies and institutions such as Wildlife Institute of India, Coast Guard and S.V.P. National Police Academy etc.

The Academy also conducts Mid-Career Training Programs for senior officers of the Indian Revenue Service (Customs & Central Excise) at critical transition stages of their career progression.

In addition to the main campus in Faridabad, NACIN also operates from 18 other locations known as Zonal Training Institutes (ZTIs) located at Bengaluru, Bhopal, Chennai, Cochin, Delhi. Hyderabad, Kanpur, Kolkata, Mumbai, Patna. Shillong, Chandigarh, laipur, Vishakhaptnam, Bhubneshwar, Vadodara and Regional Training Institutes at Raipur and Ranchi. In most of these ZTIs & RTIs. NACIN conducts induction training for Group B (both Gazetted and Non-Gazetted) and Group C officers posted in jurisdictional Commissionerates.

NACIN also has a 'Centre of Excellence" at New Delhi for undertaking research and taking measures to improve CBICs functioning and public delivery and to identify future challenges and training gaps.

NACIN's Multi-Disciplinary School of Economic Intelligence (MDSEI) is located in Mumbai with a mandate to develop capacity in the area of economic intelligence. It aims to become a Centre of Excellence in the Asian Region.

Each ZTI and CoE are headed by a Principal Additional Director General/Additional Director General assisted by Additional/Joint Director, Deputy/Asst. Directors and other support staff. Details of Sanctioned Staff are at Appendix-I.

In-service training programs are organized in the field of Customs, Goods & Services Tax (GST), Drug laws, Green Customs, Cyber Security, Anti-money laundering, Weapons of Mass Destruction, Fake Indian Currency Notes, Ozone Depleting Substances, Intellectual Property Rights, among other subjects.


NACIN has played a key role in capacity building in the area of GST, enabling the field officers to develop requisite skills for with keeping pace the current developments international and changing tax administration scenario in the country. In the GST era, NACIN is the only Academy of its kind in India that provides regular training to not only the officers and staff of CBIC, but also to GST officers/ officials of 29 States and 7 Union

Territories. NACIN has also been mandated to provide GST training to representatives of trade bodies and trade professionals. Thus, it will be catering to the training needs of around 70000 persons every year.

NACIN is a Regional Training Centre of World Customs Organization for Asia Pacific Region. Also, as a recognized centre for capacity building, NACIN conducts various programs in the field of environment protection in collaboration with the United Nations Environment Program. In addition, NACIN collaborates with the United Nations Office on Drugs and Crime(UNODC) for capacity building on drug law enforcement. NACIN has been identified as the training centre on Customs matter for the SASEC countries. The Government of India has entrusted NACIN with the responsibilities knowledge exchange and experience sharing with various countries across the globe.

1. OFFICER-TRAINEES (OT) CELL

Officer-Trainees Cell looks after the training requirements and needs of the newly recruited IRS officers.

2.INTERNATIONAL CO-OPERATION AND TRAINING (ICT) CELL

International Co-operation and Training Cell is engaged in capacity building of various foreign countries as well as Indian enforcement agencies under various MoUs with International organizations or on the request of the Ministry of External Affairs, Government of India. The courses are designed and executed according to the requirements identified by the participating members.

3. IN-SERVICE TRAINING (IST) CELL

In-Service Training (IST) Cell of NACIN, Faridabad organizes in-service advance & specialized trainings/courses/workshops on different topics of importance for Group 'A', 'B' & 'C' Officers of Customs and Central Excise Department/GST.

4. GST CELL

GST Cell of NACIN, Faridabad organizes various trainings on different topics of GST for Group 'A', 'B' & 'C' Officers of Customs and Central Excise Department/GST

5. NARCOTICS CELL

Under National Policy on Narcotic Drug and Psychotropic Substances, NACIN has been designated by the Government of India as the Nodal Agency for training of drug law enforcement in India. A separate Narcotics Cell has been created in NACIN Faridabad in March, 2018 to look after all aspects of Narcotics like policy, training, resource material, co-ordination with other agencies etc. and also to chalk out and deliver detailed training programme for the Departmental officers and also for the Drug Law enforcement officers of other Central and State Government Agencies.

6.MID-CAREER TRAINING PROGRAM (MCTP) CELL

Its mandate is to provide mid-career training to IRS (C&CE) officers at different phases of their career. It is a kind of refresher courses for officers to strengthen their administrative skills by exposure to modern managerial and administrative techniques taught by national international management institutes of repute and international standing to handle them to prepare the responsibilities of higher level management.

OFFICER TRAINEES (OT) CELL

The IRS (Customs & Central Excise) 12-month probationers undergo a induction training, which comprises of a combination of classroom training divided into basic Indirect Tax law modules and functional modules in the area of Customs, Central Excise, Service Tax, Goods and Services Tax and Narcotics and matters pertaining to Allied Acts. Other training modules include law, international trade, public finance and accountancy. administration. and training leadership and public policy from a foreign university. The IRS (Customs & Central Excise) training has been with more focus revamped on participative approach in place of theoretical classroom training in order make the trainees functionally competent with the skill sets required to discharge their duties. On completion of 12 months' training in the academy, the officers are posted in the field formations for on-job training as subordinate officers, before assuming the

independent charge of Assistant Commissioner. The training curriculum of the officer trainees is designed and reviewed regularly after taking feedback and inputs from various stake holders like trade & industry and the senior officers of the department to make the training more relevant with the changing needs of the time.

Further, a Memorandum has been signed with the National Law School of India University, Bengaluru to design and deliver a Law module for the officer trainees. A diploma is awarded to the Officer-Trainees by NLSIU on completion of the module.

For the purpose of exposing the new officers to international best practices in the field of Customs and Indirect taxation, visits are organized international universities and institutions. The 68th Batch of OTs visited WCO Brussels. Customs Rotterdam, CBRA Lausanne and WTO Geneva.

NACIN is the Regional Training Centre of Customs Organization (WCO). NACIN has also been recognized by several international bodies like UNEP, UNODC, ADB etc as the capacity building partner in the field of Customs and Drug Law Enforcement, Under the collaborations aforesaid various international bodies and under bilateral cooperation of Government of India, NACIN conducts international trainings for officials of various foreign countries in the areas of Customs and Drug Law Enforcement. Details of such trainings conducted in 2018-19 are as follows:

1. Workshop on Precursor and Chemical Control for officials of Office of Narcotics Control Board (ONCB), Thailand:

Six (6) officials from Thailand attended this workshop. During this workshop, various aspects of Precursor and Chemical Control was covered by the expert faculties. Participants were given practical demonstration and hands on training on testing of Narcotic Substances at CRCL, New Delhi. As per training curriculum, study tour to Taj Mahal was

also organized during the training programme.

15. Commodity Identification Training (CIT) "ToT" workshop conducted by U.S. Department of Energy:





IN SERVICE TRAINING (IST) CELL

In-Service Training (IST) Cell of NACIN Faridabad. organizes trainings/ courses/workshops for officers Central Board of Indirect Taxes and Customs. The endeavour is to cover a variety of relevant necessary to build capacity of the field officers to enable them to discharge their duties more effectively. training is not just limited to topics relevant and related to indirect taxation but also covers areas such as Cyber Security, Digital Forensics, Trade Facilitation, Infrastructure Development, **Data** Analytics, Prevention of Wildlife Trafficking, IPR, Green Customs etc. to enable officers to develop necessary skill sets and to build capacity to keep pace with dynamic tax administration ecosystem in the country.

- a) Department of Revenue Chair: An MoU was signed in 2016 between National Law School India University, Bengaluru and Department of Revenue (DoR) for establishment of a DoR Chair in NLSIU, Bengaluru. Currently, Shri P.R. Chandrashekhran, IRS (Retd.) is (DoR) Chair Professor. Department of Revenue (DoR) Chair has been established with the following objectives:
- 1. To consistently engage in research in all mutually agreed areas of law. The main aim of research is to strengthen the working capacity of DoR in areas of legal and policy research;
- 2. To build and maintain an updated knowledge data-base in all related areas of law for the use of DoR;
- 3. To act as 'think tank' for the DoR;

- 4. To provide necessary legal advise on demand;
- 5. To develop suitable 'training modules' in the areas to be mutually agreed upon; and
- 6. To undertake such other activities as may be mutually agreed upon;

Following Action Plan for the year 2018-19, approved by the Management Committee of the DoR Chair, was successfully implemented during the year:-

- Conducting teaching courses for the students of NLSIU, particularly in the field of Indirect Taxation;
- Preparation of Training Module for the IRS Officer Trainees on GST;
- Research on the following topics:-
- 1. International practices in VAT/GST treatment of e-commerce in services;
- 2. Identification of probable dispute areas in GST;
- 3. Studies on adequacy of IPR Enforcement Rules, 2007

NACIN Zonal Campus Mumbai, NACIN Zonal Campus Bengaluru and NACIN Zonal Campus Hyderabad have conducted trainings on the previously submitted research reports of the DoR Chair and the solutions proposed thereof have been shared with the formations of the CBIC.

b) **MoU with IIM Bangalore:** NACIN has signed an MOU with the Indian Institute of Management, Bangalore for imparting training on 'Financial Intelligence and Investigation' for DGRI, DGGI officers

and those working in Intelligence and Investigation wings of field formations and Directorates of CBIC. Officers are trained modern financial in Forensic technologies/instruments, Accounting and Auditing Methods, International Monetary Exchanges, Internet Based Currency, Black Money & e-investigation, Tax Havens. Analytics, Financial Investigation: Law and Evidence, Challenges and Emerging Trends in Frauds and Investigation etc. This would enable CBIC officers to investigate unscrupulous transactions / unearth scams in a more effective manner. In the year 2018-19, 90 officers of CBIC have been trained in three batches of the said programme.

Specialized trainings conducted by IST Cell in 2018-19:

1) Training on "Trade Facilitation **Agreement**": Ease of Doing Business is at the heart of reform initiatives of CBIC and India's consistent improvement in the World Bank's EODB Rankings is a testament to that. Sensitizing CBIC officers about the country's commitment at the WCO is an important step this direction. Accordingly, a two-days' training on "Trade Facilitation Agreement (TFA)" was organized for officers of CBIC at NACIN, Faridabad from 12th-13th April, 2018. It was attended by 32 officers of the rank of Assistant Commissioner and above.

- (i) Training on E-way Bill System for Group-A Officers of CBIC:Training on E-way Bill for Departmental Officers were organized at NACIN, Faridabad and its Zonal Campuses located in different states throughout the year. The main topics covered in these trainings were Provisions in E-Way Bill System, E-Way Bill Rules, Roll Out Plan, Role of Officers in E-Way Bill and utilities available, E-Way Bill Web System Demonstration, Demonstration of Officer's Module and RFID system etc.
- (ii) GST Refresher Trainings: GST Refresher Trainings for officers of CBIC and State GST officers were organized throughout the year by NACIN and its different Zonal Campuses. 139 sessions GST Refresher training conducted during 2018-19 which were attended by 3148 officers. The sessions were conducted by retired and serving officers of CBIC. The trainings attempted to enlighten the participants about the basics of GST Law as well as about the in GST changes Law since implementation in July, 2017.
- (iii) Sector Wise Symposium/ Workshops:GST Symposia have been organized for officers of CBIC/State

- Governments and members of trade, specific Industry/sectors by Zonal Campuses of NACIN.
- **(iv)Training to other Ministries/PSUs:**NACIN through its Zonal Campuses has organized 86GST trainings for the officers of other Ministries/PSUs during the year 2018-19, which were attended by 3148 officers.
- (v)Training programs in collaboration with GSTN:NACIN in coordination with GSTN is also providing Front End & Back End trainings to Government Officers of Centre, States and UTs.
- (ix) Frequently Asked Questions (FAQs) on CGST Law & Rules: To keep officers and stakeholders abreast with changes in GST Laws/Rules and to provide a better understanding of the said Laws/Rules, NACIN has updated the FAQs covering different topics of GST such as registration, refunds, exports, reverse charge, tax payment, tax credit etc. A compilation of FAQs is available in public domain (www.cbic.gov.in) for capacity building of officers. tax-payers and other stakeholders.

(x) GST Flyers on CGST Law & Rules:

Wherever required, NACIN has updated the already existing 51 Flyers covering important topics of GST, in consultation with GST Policy wing of CBIC. These Flyers explain important legal concepts and procedural aspects of GST in a user friendly language. A compilation of these flyers is also available on CBIC's website(www.cbic.gov.in).

NARCOTICS CELL

Under National Policy on Narcotic Drug and Psychotropic Substances, NACIN has been designated by the Government of India as the Nodal Agency for training of drug law enforcement in India. A separate Narcotics Cell has been created in NACIN Faridabad in March, 2018 to look after all aspects of Narcotics like policy, training, resource material, co-ordination with other agencies etc. and also to chalk out and deliver detailed training programme for the Departmental officers and also for the Drug Law enforcement officers of other Central and State Government Agencies.

Consequent upon its creation in March 2018, Narcotics Cell conducted following training in 2018-19:

Two (2) days' National Training Course on Drug Law Enforcement

NACIN conducted Two (2) days' National Training Course on Drug Law Enforce from 18th – 19th September, 2018 at Faridabad. During the inauguration of this training, Shri D. P. Dash, Pr DG, Directorate General of Revenue Intelligence (DRI) addressed the participants from various drug Law Enforcement Agencies about the menace of illicit Narcotic Drugs trafficking and concurrent challenges to address them. During the training programme, various aspects of Drug Law Enforcement were discussed and presentations were given by the expert faculties. Twenty Nine(29) senior officials from various Drug Law Enforcement agencies such as- NCB, DRI, Customs, State Police, BSF etc attended this training programme.




INNOVATION AT NACIN

NACIN, Bangalore was set up in 2003 after cadre restructuring of the department. A land measuring 3.12 acres (12,305 Sq. Meter) along with the old building was purchased from M/s HMT and the academy started functioning in the said premises.

- 2. The design and layout of the old building did not meet the training needs of the Academy, therefore the old building was demolished and New Complex was constructed by M/s NBCC with an objective to get 5 Star ratings under Green Rating for Integrated Habitat (GRIHA).
- 3. New NACIN Complex is constructed with a total built up area of 12,589 sq. meter comprising of Administrative cum Training Block, Hostel Block and Auditorium / Sports Block. The new NACIN campus was inaugurated by then Hon'ble Finance Minister of India Shri Arun Jaitely on 29.05.2017.
- 4. This campus showcases CBIC's commitment to green and sustainable development, good management practices and effective capacity building. NACIN, Bengaluru is a unique project and is a trend setter in this regard. The facilities at NACIN, Bengaluru are being efficiently run by an institutionalized mechanism in the form of Standard Operating Protocols which have been devised for each of the facility at the campus. The modern training halls in the academy are equipped with smart interactive boards and excellent acoustic with features of lecture capturing facility for real time/offline viewing of the lectures.

TRAININGS CONDUCTED IN 2018-19

Total of 42 courses have been conducted during the period 01.04.2018 to 31.03.2019 and 1806 officers have been trained with the total man-days of 9765.

Professional Course for IRS Probationers:

NACIN. Bengaluru has imparted Professional course for 31 officers of the 69th batch IRS Probationers. The said course included all the Basic law and functional modules and was held from 01.01.2018 to 05.10.2018. The training laid emphasis on hands-on sessions for better understanding on the application of law. During Enforcement modules extensive mock search and seizure operations along with Rummaging of Vehicles were setup and role played to familiarize the trainee officers with the required acumen and special skills involved in carrying out search and seizures.



As part of the Dispute Resolution module, Moot Court sessions were created to provide a real time courtroom experience for the trainees on the nuances of the functioning of courts.



In order to enhance and groom the trainee officers and to boost their individual traits like confidence, communication, leadership and public speaking skills, various programmes on personality development like Yoga, Sports and Cultural activities were included in the training schedule.







As part of team building activity, a trek to Kemmangundi was also organized.

Further, eminent personalities viz., Arjun Devaiah, (International Athlete), Charu Sharma (Cricket commentator), Sunil Joshi (Cricketer), Bylahalli Janardhan (noted septuagenarian cyclist) and Dr.Thimmappa Hegde (eminent neurologist) were invited to motivate the trainee officers.

Induction courses for Inspectors and Tax Assistants:

Induction Course for Inspectors and TAs/STAs were conducted wherein a total of 93 officers were imparted training on Customs, Central Excise, Service and GST. General tax Administration as well as soft skill training on ethics, Leadership, Communication, Yoga and Meditation. During this programme, emphasis was on field visits to Customs formations so as to provide hands on experience for the trainee Inspectors. Accordingly, visits were arranged to Air complex, Inland Container Depots, Airport etc. As part of team building activity, a trek to Ramanagara was organized which was well received by the trainees.

Just-In Time Training:

Just-In Time Training was a new initiative by NACIN, Bengaluru to provide training on the jobs to be undertaken by the officers immediately on joining their new place of posting after Annual General Transfer. The benefits of just in time training includes improved accuracy and faster content updates, required to perform their current jobs. This training immensely helped officers at the cutting edge level posted to Customs and GST Audit Commissionerates.

Harbor and Sea Training for Personnel of Customs Marine Wing:

In a first of its kind, NACIN Bengaluru had taken up the task of conducting a training programme for Customs officers as it was imperative for them to be well versed with the nuances of handling work related to activities at seaports which includes technicalities of survival at sea, interception of suspicious craft at sea etc in order to

prevent smuggling and other illegal activities. Accordingly, training was conducted from 03.12.2018 to 14.12.2018 (10 working days) for officers of the marine wing and Superintendent /Inspectors posted at Mangalore customs covering inter alia Harbor Training, Survival at sea, interception of suspicious craft at sea and various others topics.

Workshop on Adjudicating and Appellate Authorities:

The workshop was conducted on two days, 29.11.2018 and 30.11.2018 with sessions which included constitution and their relevance to tax laws, principles of interpretation of fiscal statutes, principles of natural justice, appreciation of evidence etc. The workshop was based on case studies on landmark Supreme Court and High Court judgments. The training was conducted based on the study material prepared by Shri P.R. Chandrashekar, Prof DoR Chair NLSUI on the subject.

All India Workshop on entrepreneurship, Empathy & Change Management:

With a view to emphasise how one can be innovative even in everyday office work to make it more systematic, easier and effective, an All India Workshop on entrepreneurship, Empathy & Change Management was held the Academy. The aim of the workshop was to impress upon the trainees that reformatory changes through value systems can be brought about with empathy and demonstrated various innovative initiatives taken by the common man who became the catalyst for change.

Systematic Approach of Training Programme for all India officers of NACIN:

The training focused on the skills that trainers require to impart training effectively. The curriculum included (a) Direct Trainers skills viz., understanding the entry behaviour of the trainees: methods different of teaching: psychology of andragogy learners; teaching techniques for extending the attention span of the learners; to be a facilitator for the trainees to have a better learning experience training (b) Training Need Analysis which includes focus to bridge the gap between ideal performance vs actual performance to achieve the organizational goals and (c) Design of Training Programme which focussed upon the need to design an effective training module based on the training needs expressed by the officers. The training module should have a specific aim and enabling objectives which are achievable.

All India workshop on Positive Change through Emotional Intelligence and Personality Development:

This workshop dealt mainly with change management and impact of organizational health, emotional intelligence and its impact on tax administration achieving professional excellence, organizational leadership and personal resilience. This workshop was well received and appreciated by the trainees.

Stress Management through posture correction:

The session dealt with possible disorder or diseases due to involuntarily adopting wrong postures and daily techniques for self posture correction along with yoga for no timers.

Capacity Building in GST:

Courses on GST have been conducted by NACIN, Bengaluru which include Trainings on GST Back-end IT application; E-Way Bill; Training on deduction and deposits of TDS under GST: GSTN Front End etc.

The various other courses include Course on Drugs and Related Laws, course on Gender Sensitization, Workshop for Internal Complaints Committee on Sexual Harassment of Women at Workplace Act and its procedures, course on Expenditure Management, Roll out of SPARROW (online APAR) for Group B & C officers of CBIC etc.

15 Days Training on Kannada Language were conducted, so as to acquaint the officers with the local language so as to have a better communication platform with the trade.

New facilities at NACIN, Bengaluru:

The following new additional facilities have been added to the existing Infrastructure projects during this year:

1. Upgradation of e-library

The facility of viewing both online and offline lectures of eminent faculties through 'Impartus Lecture Captured' has been introduced in the e-library. Also a well-furnished e-Library in the campus which has access to National Digital Library having over one lakh books on Law. An online digital Magazines "Magzter "having access to over 5000 magazines is also installed at the library.

ZTI BHOPAL

Ever since its inception in 2014, NACINZC Bhopal had been functioning from a make-shift office provided by Audit Commissionerate. Bhopal Trainings used to be conducted in the Conference Halls of Bhopal Audit Commissionerate M.P. and State Government Institutions. The Zonal Academy started imparting its trainings premises from rented at Landmark, Ayodhya Bypass, Bhopal from 8th September 2018. The built up area of this rented premises is 14,000 sq. ft. that is spread over three floors of a commercial building. The facilities include:

- Two fully equipped Lecture Halls of seating capacity of 46 and 52 persons respectively, with high-end overhead projectors, electric lecterns, LED displays and sound system.
- One furnished Computer Lab of 19 trainee-capacity with functional AIOs.
- Second Computer Lab of 24 traineecapacity furnished with furniture, and audio-visual system.
- A Conference Hall, with seating capacity of 21 persons, is fully equipped with audio-visual aids and Video Conferencing facility of RailTel.
- A Reading Room along with onlinesubscriptions of TIOL, Taxmann and GST ExCus.

Efforts made to procure Land for building the Zonal Campus of NACIN

Persistent parallel efforts were made for allotment/ procurement of land from: (i) District Collector, Bhopal; (ii) BHEL, Bhopal; (iii)Indore Development Authority; and (iv) CPWD, Indore. Around 4 acre land available with CPWD Indore has been zeroed in for construction of zonal campus. However, it would require approval from MoUD.

Induction Training of Inspectors and TA

One Induction Training course for 33 Inspectors and two induction courses for 46 Tax Assistants were conducted during the year 2018-19.





Besides, NACIN Bhopal conducted training programs that primarily covered following two categories of stakeholders:

Other Major Initiatives:

E. Apart from imparting trainings to inservice officers and other stakeholders.

some of the major initiatives undertaken by the Zonal Campus Bhopal are as under:

Learning Management System (LMS) of NeGD, MeitY for NACIN:

- 1. The sanctioned strength of Superintendents and Inspectors across the country is around 45,000 and updating their skills regularly through the traditional classroom methodology is not feasible. Furthermore, whenever a new change is affected, its nuances need to be disseminated quickly to all 45,000 odd CBIC officials. Against this backdrop, it is inevitable to shift to a new teaching methodology by advancements leveraging the in Information Technology.
- 2. With a view to enhance the efficiency of capacity building, after seeking approval from the DG NACIN, a request was made to the CEO of National e-Governance Division (NeGD), Ministry Electronics and of Information Technology, for creating independent Learning Management **System** (LMS) platform for NACIN. NeGD acceded to the request and they created dedicated LMS instance for use by NACIN.
- 3. LMS is designed to facilitate anytime, anywhere learning. It is possible to upload learning content in the form of videos, lectures, text files on the LMS. In addition, Questions and Answers can also be uploaded so that after going through the content on a topic, the learner has the option to check if he has understood the topic by taking an online test. In case the officer passes the

test, an online certificate gets generated by LMS indicating successful completion.

4. NEGD-LMS also has a **Virtual Classroom** feature, wherein up to 400 officers can join a Training and they can interact with the faculty online live, face to face, similar to a video conference setting. They can attend the training, sitting in their home/office and even on their mobile phone.

5. NeGD-LMS also has **Webinar** feature, which makes it possible to conduct a training at one location and it can be attended online by up to 1000 officers.

Use of Virtual Classroom feature of LMS:

NACIN ZC Bhopal organized a Workshop on "Pertinent Skills for drafting Adjudication Orders" at the National Judicial Academy (NJA), Bhopal on 15-16 March 2019. The lectures in the said two-days' workshop were delivered by retired and sitting Judges of the Hon'ble Supreme Court. This Workshop was attended by 19 Commissioners and 20 ADCs/JCs, in person, on the premises of the National Judicial Academy (NJA), Bhopal.

Proceedings of the Workshop were successfully shared live with a number of IRS officers from various locations across India and also from abroad, including from Kolkata, New Delhi, Mumbai, Hyderabad, Brussels and New York, who joined the classroom virtually. Some of these officers interacted with the faculty online (with video feed) very smoothly. This was the first attempt on the part of NACIN to host a virtual classroom.

Workshop on "Cyber Law and Handling of Digital Evidence":

HNACIN, ZC, Bhopal conducted two days' workshop for IRS(C&IT) officers on "Cyber Law and Handling of Digital Evidence" on 16-17 November 2018, in association with National Law Institute (NLIU), Bhopal. This University workshop was attended by 40 IRS officers, including from DRI, DGGI and Preventive formations. The resource persons come from diverse backgrounds - from C-DAC, CFSL, Data Security Council of India, NeGD, Truth labs, officers of Cyber Crime Cells from MP and AP, etc.

Now a days, digital evidence is being used to prosecute all types of crimes, including tax evasion cases. Digital

evidence poses many unique challenges. Despite the growing importance, it has been observed that very few officers are well versed in all three main aspects of digital evidence - the evidentiary aspect, the technical aspect, and the legal aspect.

Specialized understanding and protocols are required to identify relevant data, safely retrieve it, properly analyze it, and to subsequently produce it in a manner that its integrity can be established in any formal quasi-judicial or court proceedings. With a view to sensitize the OTs on these aspects, at the time of probation itself,DG NACIN was requested to consider entering into a MoU with NLIU, Bhopalto organize a customized, accredited two weeks' course for the OTs, leading to a PG Diploma in "Cyber law and Cyber Forensics". After receiving the inprinciple approval from the DG, NACIN, this office exchanged many iterations of draft MoU with NLIU Bhopal.

Setting up of Cyber Forensic Lab:

After getting in-principle approval from the Director General, NACIN, this office approached NeGD for providing technical assistance in setting up a Cyber Forensic Lab for CBIC officers at NACIN Campus. This Cyber lab shall be used to train our officers in handling and analyzing the digital evidence.

Drafting of "Digital Evidence Investigation Manual" for CBIC officers:


K.To sensitize our officers and make them aware of proper protocol for handling digital evidence encountered during any investigation, a proposal for drafting CBICs *Digital Evidence Investigation Manual*, was sent to the DG, NACIN with a request for being sent to the Board. The proposal contained draft Brief for the Board meeting. The said Proposal was approved in a Full Board Meeting of CBIC on 27.02.2019 and a Committee was formed for drafting the said Manual.

CENTRE OF EXCELLENCE

The proposal to set up a Centre of Excellence to facilitate the development of professionalism for fulfilling the expectations of the department was first mooted by CBIC(erstwhile CBEC) in 2001. However, effectively CoE was started when its own premises at NBCC plaza, Saket was acquired in 2011.

CoE was conceived as an institution for significant research in the areas of taxation, administration tax management, macroeconomic policies, fiscal federalism and other related issues. CoE is devoted to educating tax administrators, the public finance academia. and public finance policymakers.

An MoU dated was signed in 2016 between National Law School India University (a leading institute engaged in providing under graduate level education) and Department of Revenue (DoR) for establishment of a DoR Chair in NLSIU having a Management Committee (MC) at the helm of the affairs. Currently retired senior I.R.S. officer Shri P.R. Chandrashekhran is (DoR) Chair Professor.

Action Plan for the year 2018-19 approved by the Management Committee of the DoR Chair is:-

- Conducting Teaching courses for the students of NLSIU particularly in the field of Indirect Taxation;
- Preparation of Training Module for the IRS Officer Trainees on GST;

- Research on the following topics:-
- 1. International practices in VAT/GST treatment of e-commerce in services;
- 2. Identification of probable dispute areas in GST;
- 3. Studies on adequacy of IPR Enforcement Rules, 2007

NACIN Mumbai, NACIN Bengaluru and NACIN Hyderabad have been requested to carry a workshop/ Training on the previously submitted research reports of the DoR Chair so that the solutions proposed thereof may be shared with the formations of the CBIC.

For the next year assigned topics study groups comprising the senior officers of the Chief Commissioner/Commissioners (Joint Secretary to the GoI) level officers have been formulated for each of the topics who suggest the steer the Chair with latest developments in the relevant field.

THE OTHER WORK UNDERTAKEN BY COE MAY IS SUMMARIZED AS UNDER:

- Updating of Dispute Resolution Module work.
- Organizing of various workshops/ training programmers viz work shop on Deputation of officers on 19.07.2018, the welfare of ST/SC officers on 31.08.2018, one day workshop on Nudge Theory on 30.10.2018 a Symposium on CAT cases on 16.11.2018 etc.

A symposium to conduct an empirical study on impact of IPR violation on domestic industries focusing on small scale manufacturer, revenue lapses if any etc. inviting the senior functionaries of all the stake holders was organized on 26th of March, 2019. The complete study is being published by CoE and will be circulated to the different formations of CBIC.

ZTI CHANDIGARH

National Academy of Customs, Indirect taxes & Narcotics (NACIN), Zonal Campus Chandigarh came into existence consequent to reorganization exercise undertaken by the CBIC (erstwhile CBEC) in May, 2017 with the mandate to impart training to Central and the State officers in the States of Punjab, Himachal Pradesh, Jammu and Kashmir and Union Territory of Chandigarh. The campus presently located at Central Revenue Building (C.R Building), Plot No 19, Sector-17C, Chandigarh became functional at Chandigarh from June, 2017. The campus is equipped with state of the art training facilities. The Campus is headed by a Pr. Additional Director General, who is assisted by one Additional Director, two Assistant Directors and other subordinate staff.

Trainings Conducted:

Since its inception NACIN Chandigarh has been imparting training on various courses to the CGST officers as well as the officers of other departments like CAG, Department of Post, Judicial officers of Punjab & Haryana, State GST officers of Punjab/Haryana/H.P etc. During the period from 01.04.2018 to 31.03.2019, a total of 42 training courses were conducted by NACIN, Chandigarh wherein 1402 officers have been trained utilizing 4238 man days.

GST Capacity Building:

The campus has conducted 12 training courses on GST in which 335 officers and representatives from trade were also trained. A total of 05 courses on GST were conducted for the departmental officers wherein 103 officers were imparted training. Further

a total of 06 courses on GST were conducted for the officers of other Govt. Departments/PSUs like Indian Audit and Accounts Department, State GST (Punjab, Himachal Pradesh and Haryana), Controller of Communication Account-Punjab Telecom, etc. In addition, a one day workshop on e-way bill for the representatives of the Trade was conducted wherein a total of 36 members of the trade participated.

Induction Courses:

NACIN, Chandigarh also conducted 02 induction courses for Inspectors and 02 induction courses for TAs/LDCs/EAs wherein a total of 80 officers were imparted training on Customs, Central Excise, Service tax and GST, General Administration as well as soft skill training on ethics, Leadership, Communication, Yoga and Meditation.

Miscellaneous Trainings and Workshops:

One day Workshop on NDPS Act, and was conducted Green Customs NACIN, Chandigarh where a total of 19 officers attended the workshop. In addition, trainings and workshops were conducted on Gender Sensitization, Sevottam, Office Procedure Manual, Eprocurement & GeM, Right Information, E-Way bill, Implementation of E-office. CESTAM/EA-2000/Audit/Financial Accounts. A total of 959 officers were trained under these programs. Furthermore. a five-day Orientation Course for the newly promoted Assistant Commissioners was also conducted wherein 17 officers were trained.



ZTI CHENNAI

ZTI, Chennai is located at Plot No.3/86-E, Ambattur Industrial Estate, Chennai – 600 058 (in 3 floors). The Academy spanning an area of about 18,270 sq.ft has two Lecture halls (with 70 and 40 seats), one Computer Lab (22 systems), one Conference hall, one canteen, etc with rest rooms in each floor. It has enough parking space, Diesel Generator Sets for power back up, apart from open lawns in the first and second floors, thereby complementing an ambience for a training academy. NACIN, Chennai is having a Trainee hostel with mess facilities which is located at 30/2, Central Revenue Quarters, 15th Main Road, Anna Nagar, Chennai 600 040 which is about 3 km away from the Academy. There are 48 rooms (in 4 blocks), out of which 32 rooms are Air conditioned. A Guest House with 4 independent air-conditioned rooms to accommodate Senior Officers are housed and an Officers' mess is located at 505/1 & 505/2 of central Revenue Quarters. A lab with 22 Computer systems is functioning in NACIN, Chennai, and is used for imparting various computer-assisted training programmes viz. Computer Based Training (CBT) on Drug Law, EDW, CAAP Audit, ACES, e-TDS returns filing, Training on ERP packages such as Tally, Excel, SAP etc. Hardware such as thin clients, servers, printers etc related to ACES was installed in the Lab. ACES WAN connectivity has been provided and hence trainings on ACES and other areas stated above can be provided in this lab. Back-end training for GSTN too was imparted using this lab.

ZTI, NACIN Chennai has over the years grown steadily and consistently. The table below shows a bird's eye view of the progress made over the years:







A total of 130 courses were conducted during the period 01.04.2018 to 31.03.2019 and 5944 officers have been trained. Out of these

130 courses, 55 courses were conducted on GST wherein 2,837 officers were trained. The remaining 75 courses include Induction Course

for Inspectors of Customs, Central Excise and Examining officers of Customs, Tax Assistants and Courses on other subjects such as Sevottam, RTI, IPR, Gender Sensitization, Drug Laws & NDPS, Soft Skills, Baggage Rules, Anti- Money Laundering, Allied Acts for Customs like PQ, AQ, Drugs and Cosmetics Act etc., Training Vigilance and Administrative matters, etc., Auditing Tools using Tally and other ERP, AEO course for Officers as well as Trade, OSPCA for Customs officers, Enterprise data Warehousing, e-TDS, Data Hacking, Backup and Recovery, Cyber Crimes and Ethical hacking, E-Governance and Digital India Programmes, etc., wherein a total of 3107 officers were trained.





GST Roll out - Capacity Building:

- ❖ 55 courses on GST have been conducted by NACIN, Chennai which include trainings on GST Back-end IT application, Refresher Course, Training on E-Way Bill, Sector Specific Courses, Computer based hands on training GST on ACL module for officers, Hands-on training in filing of return covering both Central and State Officers of Tamil Nadu and Puducherry.
- * **GST** Awareness programmes were also conducted for various other Government **Departments** like Department of Highways, Department of Posts, Department of Atomic Energy, AG's Office. CSIR. Income Tax Department. All India Radio Doordarshan, etc., wherein 515 officers were trained.
- Awareness/outreach programmes on GST areas were held for various trade organizations /associations like Engineering Export Promotion Council, Federation of Indian Exporting Organization, Micro Small and Medium Enterprises, Madras Chamber of Commerce and Industry, Customs Brokers Association, Rotary Club, South Indian Chamber of Commerce and Chartered Industry, Institute of Accountants of India, ICMAI, ICSI, Customs Cargo Brokers Association etc., wherein 648 members were trained. During such Programmes the Trade Facilitation measures initiated by CBIC like AEO, DTP, SWIFT etc., were also extensively covered.
- * 10 Refresher Courses encompassing latest changes in the GST laws were conducted by NACIN, Chennai for officers of both Central Government and State Government wherein a total of 234 officers were trained.
- **04 backend courses on GSTN** were conducted by NACIN, Chennai resulting in the training of 96 officers.

- ❖ 8 Sector specific courses on GST like Construction and Real Estate sector, Travel & Tourism, Telecom, Manufacturing, Import / Export, MSME, E-Commerce, Job Work, Gems & Jewellery, Textile, Banking, Finance & Insurance, Media & Entertainment, Automobile, Logistics, Aviation, etc., were conducted by NACIN, Chennai wherein a total of 240 officers were trained.
- **269officers** form the Tamil Nadu State GST were trained as a part of Refresher Training Programmes and Sector Specific Training Programmes.

Unique Programmes:

- **a) TOT:** ZTI, Chennai held All India programme for Trainer of Trainers on
 - Risk Management System (RMS) & Post Clearance Audit (PCA),
 - ii. **SWIFT**,
- iii. **AEO Web Applications** which were well received by the participants pan India.
- b) This Academy had also conducted an Awareness **Training** Programme **Ouarantine** on Plant Regulations association with in National Institute of Plant Health and Management, Hyderabad and two Refresher courses for the Authorized officers of Food Safety and Standards Authority of India, Chennai.
- c) Training for Authorized Officers under FSSAI was conducted by the ZTI for Officers of Customs from entire south India which was attended by 73 Officers.
- d) Trainings on Information Security, Data Pilferage and Cyber Laws were conducted onsite at various Commissionerates (Trichy, Salem,

- Chennai North, Chennai South, Chennai Outer Commissionerates) which were well received by the officers participated.
- **e)** A **TOT** on **GSTN Front-end** training for officers of CBIC & Puducherry GST was conducted by this ZTI in association with **GSTN** which was attended by 56 Officers.
- f) As another innovative initiative taken by NACIN, Chennai was to disseminate the knowledge of GST to the next Generation College Students, NACIN, Chennai had organised Two day and Five Day GST Sensitization Programmes for around 6 Colleges in Chennai and covered 828 students as part of outreach programmes. These trainings were conducted by NACIN Faculty onsite at the respective Colleges and at the premises of this Academy.
- **g)** NACIN, Chennai had organized a **Faculty Development Programme (FDP)** for the faculty of University of Madras and the faculty of various colleges affiliated to University of Madras, on GST legislations on 13-12-2018 and 14-12-2018 which was attended by 75 trainees ranging from Professors, Associate Professors, Assistant Professors, lecturers and research scholars.
- h) The faculty of NACIN, Chennai have been included to be part of the Academic Councils of University of Madras, Loyola College, and Alpha Arts and Science College to design the course content and syllabus on GST for Commerce Graduate students of respective colleges.
- i) A dedicated Two (02) days course on Cyber Security, Information Technology Act 2000, Digital Evidences and Big Data Management was conducted by NACIN, Chennai in coordination with the Cyber Society of

India on 12-02-2019 and 13-02-2019 wherein around 35 officers across the cadre had participated.

j) NACIN, Chennai had organized a Seminar on "Wildlife Crime, Global and Domestic Controls" wherein an International Faculty Dr. Slavomir Redo, Senior Advisor, Academic Council, UNS, Vienna, Austria had trained about 40 officers of Customs from across Tamilnadu and Puducherry.





k) As an innovative initiative and as a part of confidence building measures for the newly recruited Inspectors of GST, C.Ex, Preventive Officers and Examining Officers, NACIN, Chennai has included a **Public speaking session** as part of the Induction Course schedule, wherein trainee Inspectors are given a platform to speak on a topic of their choice for a duration of around Ten minutes to express themselves. This

initiative received very good feedback from the visiting faculty of NACIN and all quarters. This has helped the newly inducted inspectors to shed their inhibitions to speak in public and improves their communication skills. It is suggested that this "Best Practice" adapted by NACIN, Chennai may be replicated in other Zonal Training Institutes also, if found feasible. It is also suggested that the duration of the Induction Training which stands at 8 weeks now can be increased to 6 months and training can be given on similar lines as it is being done for Probationers with a compulsory final evaluation test.



- l) As the most of the newly recruited Inspectors are from Non-Tamil speaking areas, especially from North India, NACIN, Chennai has inducted as part of the Course schedule "Spoken Tamil sessions" as a part of Induction Training Programme, which will enable the officers to effectively communicate with trade when posted in field and discharge their duties proficiently.
- **m)** As part of Seven week Induction Course for newly recruited Inspectors, they were sent for the Two week training of Arms and Ammunition at Tamil Nadu Police Academy (TNPA), Chennai. As a part of this training, the trainee inspectors participated in various Confidence Building activities

like Rock Climbing, Rappelling and other outdoor activities.

DETAILS OF INFRASTRUCTURE AVAILABLE WITH ZTI, COCHIN

NACIN, ZTI, Cochin is presently functioning from a rented premise at 3rd& 4th Floor, M.T. Plaza, Kaloor- Kadavanthra Road, Cochin. A permanent campus is planned to be built at Munnar, Kerala for which the land/plot has already been acquired and the construction is due to begin soon. Some of the infrastructure facilities currently available are as mentioned below:

- The campus has two training halls. with capacity one a accommodating 50 trainees (extendable up to 80) and the other one has a capacity to host a maximum of 35 trainees. Both the training halls are equipped with state-of-the-art technologies like ultra-short throw projectors. high-speed internet connection, air-conditioned halls, well suited sound systems, etc. just to name a few.
- A fully equipped Computer Lab, having a total of 30 systems (15 GSTN plus 15 normal computers), is also available with the institute for providing a hands-on training on GST Backend Application to the participants besides enabling the conduct of courses on topics such as MS Word, MS Excel, etc.
- The Academy has a fully operational Video Conference facility

- available thereby enabling officers as well as trainees to remotely benefit out of the different courses being conducted by other ZTIs.
- For the benefit of trainees and for developing a firm knowledge base, the institute is in the process of setting up a library as well which apart from the regular departmental books will have books on general subject areas, inspirational books and other weekly/monthly periodicals.
- Being a small establishment with limited staff, there is no canteen facility available presently in the campus. However, a small area in the office is in the process of being developed as a functional pantry which will have facilities like fridge, microwave, coffee vending machine etc.

ZTI DELHI

The Regional Training Institutes (RTI) under NACIN were came in existence in 1996. The RTI Delhi was given the responsibility of training the officers of CBIC and Narcotics from North Zone comprising of the states of J&K, Punjab, Haryana, Rajasthan, Himachal Pradesh and Delhi. Over the years, RTI, NACEN has been successfully conducting professional training of the Group A, B & C officers. The RTI Delhi was located at Pushp Bhawan, Madangir Road, Delhi. With the introduction of GST and consequent reorganization of field formations of CBIC, the RTI has been re-designated as the Zonal Training Institute (ZTI) with its jurisdiction over the State of Haryana and the NCT of Delhi. In order to improve the training facilities, the ZTI was shifted from Pushp Bhawan to NBCC Plaza, Pushp Vihar, Sector-5, Saket, New Delhi. It is now located in a fully airconditioned building with state of the art classroom halls. It has 1 lecture hall, 1 computer lab, 1 conference room with video-conferencing facility, 1 library and a cafeteria. The ZTI, Delhi is headed by a Pr. Additional Director General, who is assisted by an Additional Director, three Assistant Directors and other subordinate staff.

To achieve this goal, ZTI Delhi regularly review its course modules.
- Arms training is one of the mandatory part of Induction training of Inspectors. Earlier it was done with collaboration of Delhi Police Training Academy, Jharoda Kalan, Delhi and this was nonresidential where participants report in morning every day. A healthy mind stays in a healthy body and this was our mantra while formulating new Induction course curriculum therefore changes in Arms training module was adopted. In 2018-19, ZTI Delhi conducted 3 Induction courses and officers joined one week residential arms training at BSF Training Academy, Tekanpur, Madhya Pradesh and BSF Training Academy, Chawla, Delhi during the Induction courses.

After compiling of all the feedback only those faculty are again invited who are found deliberate, communicative and effective. For this goal this organization also contacted to other training academies time to time.
- ➤ ZTI, Delhi has felt that apart from professional competence general competency of the officers matters a lot. Keeping this fact in consideration, skill development related courses has been conducted regularly onsite also. ZTI, Delhi therefore conducted workshop on **Artificial Intelligence and** & Data Analytics.

- Customs officers are the sentinels of the borders and have been rendering service to the nation by preventing smuggling of gold, narcotics, currency etc along with this officers at Airports are the public face of Department as well as Government of India on the broader view therefore **04 Interpersonal skills and intelligence workshops** have been conducted for officers at NCH and IGI Airport, Delhi along with course on FSSAI for clearance of food related consignments in collaboration with FSSAI.
- ➤ Three days orientation training for newly recruited group 'B' officers of Customs Marine wing was also organised successfully at NACIN, ZTI, Delhi. Video Conferencing on APAR writing and seven half day sessions on Implementation of e-office lite (Sparrow) & PIMS for CBIC employees were organised. TRAININGS CONDUCTED DURING THE YEAR 2018-19

INDUCTION TRAINING COURSES FOR THE NEWLY RECRUITED / PROMOTED INSPECTORS:

One of the key mandate of the Institute is to organize induction training courses for the newly recruited promoted Inspectors. The officers were also apprised about how to collect, identify and analysis the digital data, without damaging its evidentiary value in the court of law.



TRAINING ON WTO TRADE FACILITATION AGREEMENT

A two days training on WTO Trade Facilitation Agreement was organized in August, 2018 with the idea to familiarize the participant with National TF Action Plan, Implementation of some important provisions of TFA and recent legal and procedural amendments to align India's trade regime with TFA.



Apart from the above, 16 other trainings covering variety of Statute based topics and soft skills were organized. During the year 2018-19, 44 courses were organized in which 1240 officers participated. A total of 5780man days of training were imparted.

MULTIDISCIPLINARY SCHOOL OF ECONOMIC INTELLIGENCE

The idea of exploring the feasibility of setting up a Multidisciplinary School of Economic Intelligence to develop capacity building in the area of economic intelligence and to become a Centre of Excellence in the Asian Region was first mooted by the Hon'ble FM in the Economic Intelligence Council (EIC) meeting on 18.01.2010.

A detailed roadmap for setting up MDSEI titled "Modalities for setting up and operationalizing the MDSEI" was prepared by CEIB and NACEN which was approved in principle in the EIC meeting on 28.2.2012 and NACEN was formally mandated to set up and operationalize the MDSEI. It was decided that the primary focus should be on major organized crime, racketeering and frauds requiring strategic collection and development of information across jurisdictions and countries.

NACIN Mumbai is regularly conducting specialized courses under the aegis of MDSEI and has conducted 12 courses upto FY 2018-19 on topics such as Capacity building on Economic Intelligence, Prevention of smuggling of FICN and foreign currency, anti-money laundering, cyber forensics, Ponzi Schemes, illicit trafficking of wildlife etc. A detailed list is as follows:

ZTI MUMBAI



NACIN ZTI Mumbai located at Bhandup (East) is a two acre campus with state of the art training facilities. NACIN Mumbai has been catering to the training needs of Groups A, B and C officers posted at Customs & CGST Commissonerates and Directorates in the Western Region comprising Maharashtra and Goa. NACIN is at the forefront of GST Training and has trained all the Central and State Government Tax officers in Maharashtra and Goa. Besides, NACIN

has created learning resources such as GST FAQs and flyers and conducts GST Symposiums every week/fortnight. A total of 144 courses have been conducted during the period from 01.04.2018 to 31.03.2019 and 3747 officers have been trained. A total of 21997.5 man days were achieved. Out of these 144 courses, 41 courses were conducted on GST with man days numbering 1538. The remaining 103 courses include Induction Courses for Inspectors (Prev. Officers& Examiners of Customs) and CGST officers and courses on other subjects such as Sevottam, Soft Skills, Wellness, Vigilance & Inquiry Proceedings, Drug Law Enforcement, Cyber Forensic, Basic Computer, Advanced Computer, RTI, Financial Accounting, Courses for IOs/POs, TFA Courses etc. In addition to the above, NACIN, Mumbai has also conducted the Training for 31 Officer Trainees of the 69th batch of IRS Probationers from 1st Jan, 2018 to Oct 2018.

MDSEI: A one day Workshop on non-realization of export proceeds-A multi Agency perspective was conducted on 28 January 2019, under the aegis of Multi Disciplinary School of Economic Intelligence (MDSEI), The workshop was attended by 55 officers from various formations/agencies across the country viz from CGST &C.Ex, Customs, Customs (Prev), DRI, DGGI, ED, SFIO and the Banking sector. One more Workshop was conducted in FY 2018-19 under the aegis of MDSEI on 18 – 19 March, 2019 on 'Analysis of GST frauds involving fake invoices' organized by MDSEI at NACIN Mumbai. Chairman CBIC Shri P. K Das & Member(Admn) Shri R.K. Barthwal inaugurated the Workshop via video conferencing. 88 officers from CGST, Customs, ED, DGARM, DGGSTI& GSTN attended.

IRS Officers Training: Professional training for 31 Officer Trainees of 69th Batch of IRS Probationers was conducted at NACIN Mumbai. In continuation of the Leadership Series drawing eminent personalities from the fields of sports, entertainment, Arts, Economics and Govt., Shri Naseeruddin Shah, veteran actor visited NACIN Mumbai and interacted with the OTs. In this 'Tryst with the Thespian', he shared inspirational stories from his life as also candid views on cinema and theatre in India.

The Officer Trainees formed various Committees such as Social Service, Sports, Infrastructure, Cultural, Library and Academics etc. The Journal Committee printed a journal titled 'The Story of Us' depicting the journey of training of 68th and 69th batches of IRS probationers at NACIN Mumbai.



GST: As mentioned above, 41 courses on GST have been conducted by NACIN, Mumbai which include Trainings on GST Back end It application, GST training for Customs officer (Outreach course), Workshop on GST, GST Symposiums on various topics, various workshops on GST & GST Refresher courses.



PPTs were made on weekly changes in GST Law & procedures proposed by the GST Council and circulated to all NACIN RTIs/ZTIs & Chief Commissioners offices. Also, Video Conferences were held every fortnight wherein fortnightly updates on GST were discussed. In FY 2018-19, 51 such VCs were conducted.

Besides this GST symposiums were regularly conducted wherein issues in respect of specific industries were discussed. 22 such symposiums were held in FY 2018-19.

Five Refresher trainings on GSTN backend were held wherein hands-on training was

imparted on GSTN back end applications. Workshops on TDS in GST and GST evasion due to Fake Invoice-Cause & Effect were also conducted. A report was sent to CBIC suggesting ways to stop the menace of fake invoices.

3rd edition of GST FAQs in which additional questions & Chapters were added, was released on 19.12.2018 by Shri S. Ramesh, Chairman, CBIC & Shri R.K Barthwal, Member, CBIC.

A question bank of more than 5000 multiple choice questions on GST Law and accounts were prepared for use in various examination/tests.



OTHER TRAININGS/ACTIVITIES

- ➤ A course for Air Force Officers from Material Management Institute, Devlali was organized on 22.2.2019 on Customs and GST focusing on various exemptions for Defence as well as its vendors.
- ➤ A two week course for Indian Trade Service (ITS) probationers from Ministry of Commerce was conducted from April 9-20, 2018 wherein GST & Customs procedures were covered.
- ➤ The Academy also trained officers from organizations such as State Excise, Mumbai Police, Coast Guard, Indian Army etc in addition to departmental officers on Drugs Law Enforcement. In FY 2018-19, two such four day training courses were conducted at NACIN Mumbai and one in Goa on Dec 10-12, 2018.
- ➤ A total of 7 Induction Trainings for Inspectors of CGST and Customs (Preventive Officers and Examiners) were conducted in FY 2018-19.

- ➤ Other than regular training programmes, NACIN is also frequently organizing outreach programmes for various Organizations as well as Commissionerates. An important element of these outreach programmes is to provide access to learning resources and serve as a learner support system on a variety of subjects. Some of the topics are GST, soft skills and Sevottam.
- ➤ A five day 'Summer Camp" was held from May 21-25 2018 for 28 children between 8 to 13 years of age. Activities such as Drawing Painting, Origami, Calligraphy, Fun with Science, Nature Trail at NACIN, Basic Yoga, Personality development, Badminton and Table tennis were held. A one day 'Career Counseling for Youngsters' was also held on May 26 2018 for children between 13-17 years of age.



ZTI PATNA



The Regional Training centre of National Academy of Customs, Excise & Narcotics was established at Hazaribagh (Jharkhand) as on 4th April 2002 and was inaugurated by the then Hon'ble Minister of Finance, Shri Yashwant Sinha. The said Regional training center was shifted to Patna in 2005. The academy was shifted in a rented building i.e. 668, Prasad mansion, Rajendra Path, Patna (Bihar). Thereafter the academy was again shifted in the building of Circle Telecom Training Centre Building, Buddha Marg, Patna in October 2014. At present academy is functioning at 6th Floor, Block C, D, E & Part of G, Karpuri Thakur Sadan, Kendriya Karmchari Parisar [GPOA], Ashiyana Digha Road, Patna. The carpet area under academy is 9940 sq Ft (approx.). This academy has 02(two) Classrooms, 01 (One) Computer Lab, 01(One) Library, 01 (One) Conference hall apart from regular office space. ZTI, Patna is a zonal training institute catering to the training needs of the officers/staffs posted under the CCO, CGST & CX, Ranchi Zone, Patna and Commissioner Customs (P), Patna, which covers two, states namely Bihar & Jharkhand. RTI RAIPUR

NACIN, RTI, Raipur has been imparting training in Indirect Taxes and Narcotics for the past three Years catering to the training needs of Group 'A', 'B' and 'C' officers posted at Customs and Central Excise Commissionerates/ Directorates in the State of Chhattisgarh.






ZTI SHILLONG

In the month of September 2017, this Academy relocated from the Customs premises to rented building comprising 2 floors with a floor space 0f 8832 sqft owned by the Meghalaya State Housing Financing Cooperative Society Limited, which is located in Nongrim Hills, Shillong-793003.

In the month of January 2019, this Academy rented building for hostel comprising 1 floor with floor space of 2709 sqft owned by the Meghalaya State Housing Financing Cooperative Society Limited, which is located in Nongrim Hills, Shillong-793003. The hostel comprises 5 rooms with 19 beds, out of 5 rooms one room with 4 beds is exclusively reserved for female trainees.

NACIN, ZTI, Shillong organized the **GST Audit Training** at Shillong, where a total number of 3 courses were conducted and 75 officers participated during the period from April, 2019 to December, 2019.

The State Tax Dept. of Meghalaya also requested **training on GST** for its officers which NACIN, ZTI, Shillong conducted from 14th to 15th October, 2019 where 89 officers participated.

NACIN, ZTI, Shillong organized the **Induction Training Course for Inspectors of CBIC** at Shillong, where a total number of 3 courses were conducted and 62 officers participated during the period from April to December, 2019.

NACIN, ZTI, Shillong organized the training on GST for the Officers of the Tax Cell of MeECL and its subsidiaries

at Shillong on 16th September, 2019 where 46 officers were participated.

NACIN, ZTI, Shillong organized the **CBIC-GST Backend Refresher Course** at Shillong during the period from 27th may to 28th May 2019 where 33 officers were participated.

One day Session on Financial management has been conducted by NACIN, ZTI, Shillong at Shillong on 18th September 2019 where 39 officers were participated.

Mandatory Training of Executive Assistants for Promotion to the post of Administrative Officers has been conducted by the by NACIN, ZTI, Shillong at Shillong during the period from 02nd to 13th December, 2019 where 34 officers were participated.

One Day Workshop on Combating Wildlife Trafficking for CBIC officials has been organized by NACIN, ZTI, Shillong at Shillong on 18th November, 2019 where 35 officers were participated.

NACIN, ZTI, Shillong organized **One Day ICES Training** on 26th April, 2019 where 49 officers were participated.

Mandatory Training for Promotion to the grade of Superintendent was organized by the NACIN, ZTI, Shillong at Shillong during the period from 3rd to 13th December, 2019 where 112 officers were participated.

Workshop/ Interactive Session on Integrity/Probity was held in Shillong

during the period from 05th December to 6th December, 2019 where 183 officers were participated.

Two days Management Development Programme for 1997 & 1999 Batch IRS Officers was held during the period from 29th to 30th April, 2019 where 16 officers were participated.



ZTI VADODARA

The Zonal Training Institute (ZTI) of NACIN was set-up at Vadodara in the Year 2002. Initially, this Institute catered to the entire state of Gujarat and also to the training needs of M.P. viz. Indore and Bhopal Commissionerates. Subsequently, NACIN, RTI in Bhopal, was created for the state of M.P. Initially, this ZTI operated from a two-room residential flat in the Central Revenues Colony, Vadodara. Because of lack of infrastructure, most of the Courses were conducted jointly with ZTI, at Mumbai only. From December, 2008 onwards all the Courses are regularly being conducted by this ZTI at Vadodara independently. Presently, this ZTI functions from the GST Bhavan, 2nd and 3rd Floor, Subhanpura where Central GST & Central Excise, Vadodara-II and Audit Commissionerates are also located. This ZTI caters to the training needs of in-service departmental officers of CBIC working in Gujarat and also the State GST official of Gujarat. Most of the Courses conducted by ZTI Vadodara are interactive and participatory in nature. Along with physical fitness through morning Yoga/ Games etc., it is also ensured that the trainee officers get adequate exposure to the real-time work environment situations through field visits to Factory, ICD, SEZ, Port etc. Police Training is also provided to familiarise the trainees with handling of small arm in preventive operations. The social aspect is also covered through the village visit, classes on music and culture as a part of long term training programmes.

ZTI Vadodara not only provides in-house training but it is also servicing on demand at the doorstep of various field formations and stake holders. Apart from Vadodara, workshops have been conducted and trainings have been provided at Ahmedabad, Kandla/ Mundra Port & Surat.

NACIN, Hostel: Upgradation and renovation of NACIN, Hostel facility was also taken-up with the help of CPWD in this financial year. The four Type-III Flats in the Central Revenue Colony have been re-designed and converted into 16 beds hostel, fully air conditioned and attached W.C. in six rooms, modern kitchen, fully furnished dining and drawing room.

Virtual Classroom at ZTI, NACIN, Vadodara:

From the formal way of teaching which was a carryover of the twentieth century to the modern, dynamic, interactive way of learning, ZTI, NACIN, Vadodara has taken measures to introduce the digital way of learning.

Computer aided content delivery will make the trainers more productive and the subsequent trainings more value creating. These classrooms will create a fundamental transformation in the quality of officers which the department strives to inculcate in its officers at all levels.

A virtual, interactive classroom has been established with a modern state of the art DLP Short Throw Projector System with a large visual display and training though long distance video conferencing facility at all other locations at the same time.

A brief on performance of ZTI, Vadodara:

A total of **100** courses have been conducted by NACIN, Zonal Campus, Vadodara during the Year **2018-19**, wherein 3226 officers have been trained. This number translates into 13136 man-days of training for the whole year. The other courses conducted include viz. GST Audit, Vigilance, RTI, IPR, NDPS, Soft Skills, ICES, Green Customs, Gender Sensitization, UNODC etc. Further, NACIN Zonal Campus, Vadodara has also conducted the Training on Export Module for IRS Probationers at two locations viz. at Faridabad and Mumbai. 






RENOVATION OF LECTURE HALL NO. 2:

SWACHHATA INITIATIVES BY ZTI CHENNAI

Two main projects were taken up as a part of Swachhta Action Plan 2018-19. The first project was Adoption a local Govt. Panchayat Union School for carrying activities under the heading **IEC** (Information, Education Communication) which includes Painting, Fixing of pipes for Providing drinking water, creation of space to carry out bare minimal activities relating to education like blackboards, storage space for bags of children, re-furbishing of the mid-day meal kitchen, Fix a gate for protection of children etc., Plant saplings of trees & set up a garden in the premises. Renovation of the toilets & repairing an existing borewell for water supply to toilets. The work has been completed in the second week of February, 2019.

The second project taken up was Painting the walls of the NACIN Hostel & Renovation of toilets for providing clean rooms for the trainees. The work has been completed in respect of 15 Hostel rooms. The remaining work will be completed by the end of March, 2019.

Apart from the above Essav poster competitions and making competitions on Swachhta were conducted for the trainee inspectors attending Induction Course during Swachhta Pakhwada. Drawing competitions were also held for the students of the local Government Higher Secondary Panchavat Union Primary School on theme Swachhta and prizes distributed to the winners and the participants.

The Academy also carried out a cleanliness drive at Ambattur Industrial Estate. The officers & staff cleaned the streets and cleared plastic waste and debris from the area.

As a part of Anti-Plastic drive, the officers and staff of the academy distributed pamphlets to general public and also distributed Jute bags with antiplastic slogan to the officers, staff, visiting faculty and to school students. Bio Composters were purchased for disposal of wet waste in a useful way.

SWACHHATA INITIATIVES ZTI BENGALURU

Premises:Under Swachh Bharat theme, NACIN has carried out beautification work outside NACIN main gate by planting various plants and flowers. These plants and flowers also include some endangered species of plants and flowers. This is being maintained by NACIN on day to day basis.





Rain Water Harvesting:

A comprehensive Rain Water Harvesting system has been implemented in the campus so as to capture and utilize every drop of rain that falls in the campus. The system consists of two separate parts, i.e., a rooftop rain water harvesting filtering and a storage system for potable use

rooftop and surface runoff and rainwater harvesting and recharging system. The rainwater from the rooftop of Administration and Hostel block is being collected and channelized to a filtered water is directed to the underground sump which is further used for NACINs daily needs. Water so collected after a round of good rains, is sufficient to cater to the needs of the academy for 5 to 6 days. Rainwater from other buildings in the campus and the surface run-off water is channelized through storm water drain to the aguifers. This improves the water table level in and around the area thereby replenishing our bore wells, which are the sole means of fresh water in this campus. Rainwater harvesting makes up to 7% of the total water requirement annually.

Eco-Friendly measures adopted at NACIN, Bengaluru:

 The campus is a "Zero Garbage Zone" and is equipped with a Bio-filtration Sewage Treatment Plant and an Organic Waste Convertor.



 Solar Roof Top Photo Voltaic (SRTPV) Plant is installed at the academy. The electricity generated by SRTPV Plant substitutes 47 % of total internal lighting energy requirement.



 The campus has been landscaped with 100% green cover which includes unique herbal garden theme. Herbal Garden also includes medicinal and aromatic plants, pests and mosquito repellent plants.



 Innovative Trenching technique around trees has been implemented in the garden which helps in excellent rainwater retention and percolation is also possible with this method.



SWACHHATA INITIATIVES ZTI COCHIN

The Zonal Training Institute, NACIN, Cochin was allocated a budget sanction of Rs. 5,00,000/- under the budget head OE Swachhata for the year 2018-19 with directions to utilize the same for activities such as creating awareness regarding cleanliness among staff, department's stake holders and general public, keeping office premises clean, etc., thereby mainstreaming sanitation and cleanliness activities as required under the Swachhata Abhiyan. The activities undertaken by this institute hold greater importance in the context of 'Swachhata' as this year being the 150th Birth Anniversary of Mahatma Gandhi.

Unlike last year where the ZTI Cochin was working with limited infrastructure facilities and was based out of two room space being provided by the Customs Preventive Commissionerate, Cochin, this year the institute started functioning from an independent hired building having two floors and training halls as well. As mandated under the Swachhata Abhiyaan (Swachhata Action Plan), various initiatives were undertaken for improving the ambience of the office space/ work stations viz., fabrication works undertaken in order to have requisite chambers/ rooms for the officers and staff, purchasing curtains and blinds for the training hall and other rooms/cabins for officers/staff, wallpaper and painting works etc.

In a bid to discourage the use of plastic, file-folders made of jute with a slogan "say no to plastics" and 'paper seed pens' in place of normal ball-point pens are being distributed to trainees undergoing various training programmes organized by this institute. Also, Jute Bags with Swachhata slogans are given to officers attending induction trainings.

Taking Swachhta initiatives forward, this institute identified various Govt. Schools and orphanages in the locality and made the best of efforts possible to address their requirements with regard to cleanliness, sanitation, need for clean drinking water, etc. The details regarding some of the works/projects undertaken are as follows:

Govt. Girls Higher Secondary School, Mattancherry: The school was in requirement of clean drinking water facility and some modifications which were to be done in the wash-area owing to which a problem of water-logging was being faced. Taking into cognizance the problems highlighted, a visit was made to the premises and proper assessment of the prevailing situation was done. Further, cleaning of the school compound, rectifying the issue of water-logging, repair of water tank for drinking water and other necessary plumbing works required were undertaken and completed.

Govt. Higher Secondary School, Elamakkara: This school presented with requirements such as installation of a water purifier for clean drinking water, sanitary napkins vending machine, wall mounted urinal bowl for boys, pressure pump, a pressure motor for pumping drinking water, etc. After taking into consideration various factors such as urgency and available budgetary provisions, the above said requirements were addressed to and facilities such as installing a water-purifier and sanitary napkin vending machine, and a pressure pump and 1.5 HP motor were provided under the Swachhata Action Plan.

Govt. Home for Physically handicapped (Women), Thevara: As cleanliness drive in orphanages is also suggested as an activity to be undertaken under Swachhta Action Plan, the issue with regard to sanitation and availability of clean drinking water at the 'Home for Physically Handicapped Women' was considered and steps were initiated to provide an effective and early resolution for the same. The issue of a choked septic tank which was posing both as a health and environment hazard was addressed and the problem was rectified.

Govt. Sanskrit High School, Thrippunithura: As part of the 'Swachhata Pakhwada' to be observed in the Department of Revenue from 15.10.2018 to 31.10.2018, a visit was made to the school and it was identified that there were requirements like cleaning of the school compound, provision for clean drinking water, and other sanitation related works. Addressing the requirements, the school compound was got cleaned and water purifier was installed along with a storage tank, plumbing and electrical provisions were made for the purifier already available with the school.

SRV Govt. (Male) VHSS & HSS, Ernakulam: An email communication stating need for renovation/maintenance of toilets and provision for clean drinking water was received from the school authorities and a visit was made to ascertain the exact requirements regarding the same. It was found that the school was in requirement of a motor to pump drinking water, two 1000 lts. water tanks, replacement of water taps and installation of a water filter. After ascertaining the requirements and in accordance to the budgetary provisions available under the Swachhata Head, works such as plumbing to avoid seepage of waste water into drinking water, sump tank modification, cleaning of toilets, were done. Also, the school was provided with 2 (two) water tanks of 1000 lts capacity each and a water purifier along with a storage tank of 50 ltr capacity.

Govt. HSS, North Paravur, Cochin: A requirement of water purifier along with a storage/dispenser tank was received from the school. Provisions were made for the same and the purifier is being installed thereby ensuring availability of safe and clean drinking to the students.
